Analysis of Global Car Production & Sales in the 1st Half of 2016-Europe, Asia and N. America Continue to Take the Lead by Gang Hao Chang, Fastener World

It's a new year again! Global cars and related auto parts manufacturers are also ready to demonstrate their strengths in 2017 and search for potential business and investment opportunities in the global market. In this article, we'll review the "Global Car Production & Sale Statistics in Q1-2 2016" recently released by OICA, which shows the trend of car production and sale in Europe, N. America, Latin America, Asia, Africa and Oceania and see whether or not there are some potential opportunities in certain regions for companies interested in tapping into the markets in 2017.



DRODUCTION

The world produced 46.5 million cars in the first half of 2016. Car production in Europe and Asia (incl. Oceania) in recent years has continued to show stable growth. The production in Europe and Asia in the 1st half of 2016 showed a 4.3% and 2.3% growth respectively or 11.5 million and 24 million units of vehicles (production in Asia was more than the double of Europe); the production in N. America showed growth as well and the production was nearly 10 million units of vehicles; production in S. America was decreasing year after year and production in this region was less than 2 million units of vehicles. All countries in these region showed a decline of over 10.0%; production in Africa was less than 0.3 million units of vehicles. This region for car production is still underdeveloped.

Europe (incl. Russia, CIS and Turkey)

Top 5 car production countries in the 1st half of 2016 were Germany, Spain, France, UK and Czech Rep. and production of these five countries was over 60% of the total of Europe. Spain and UK both showed growth of over 10.0%. If we view by country, Sweden showed the highest growth of 36.3% while Finland showed the most significant decline of -20.0%. However, neither Sweden nor Finland reached the production of 0.2 million units of vehicles. Car production in Europe is mainly concentrated in W. Europe. However, countries in E. Europe like Czech Rep., Slovakia, Poland, Hungary and Romania have been also trying their best to keep the pace with the leading countries in recent years. According to the data in the 1st half of 2016, Czech Rep. and Slovakia both reached the production level of 0.5 million units of vehicles. As for Russia (incl. CIS), the total car production in this region in the 1st half of 2016 reached only about 0.6 million units of vehicles, which does not seem good. Compared to the record in 2015, production in Russia was down 16.2%. Production of Turkey in the 1st half of 2016 was nearly 0.8 million units of vehicles, up 8.7% from 2015.

Asia (Incl. Oceania)

Car production in Asia (incl. Oceania) in the 1st half of 2016 reached almost 25 million (higher than the total of Europe and America) and it's currently the most important car production region around the world. Top 5 car production countries in this region were China, Japan, S. Korea, India and Thailand. Undoubtedly, China is the largest car production country in the world and its production in the 1st half of 2016 was nearly 13 million units of vehicles (even higher than the total of Europe or America). China and India both showed a year-on-year growth of 6.5% and these two countries were the only two countries among the top 5, which still reported growth in the 1st half of 2016. Japan, S. Korea and Thailand all showed a decline of at least -3.0% in the production. Thailand, though among the top 5, showed the production of less than 1 million units of vehicles in the 1st half of 2016 (even lower than 1/2 of the production in India). Asian country reporting the most significant decline in production in the same period was Malaysia, which showed a decline of nearly -20.0%.

America

Car production in America (N. America + S. America) in the 1st half of 2016 was roughly 11 million units of vehicles, a slight drop of 1.0% from the same period in 2015. If N. America and S. America are viewed separately, N. America showed a 2.2% growth with the production being more than 9 million units of vehicles, but on the contrary S. America showed a nearly -20.0% decline in production, which fully reveals the fact that the important car production region in America is in the North but South. USA has been always the most essential key role in car production of America. In the 1st half of 2016, U.S. car production was about 6.2 million units of vehicles (more than 1/2 of the total of the entire America), showing a year-on-year growth of 2.1%. In addition to the largest car production country in this region- USA, Mexico, Canada, Brazil and Argentina were also other main car production countries in this region (Production of each of these counties in the 1st half of 2016 was in the range of 1-2 million units of vehicles). In addition to the growth in USA, a 13.1% growth was also observed in Canada. However, in other main car production countries, the production was on a decline. Brazil and Argentina both showed a decline of over -10.0%.

Africa

Car production in Africa in the 1st half of 2016 was approx. 0.3 million units of vehicles, showing a year-on-year decline of -4.0%. Car production in Africa was highly concentrated in South Africa. Though Egypt was the 2nd largest car production country in the region, its production was just a very small part in terms of the total. Production in Africa, if viewed from the global perspective, is hardly able to cause any impact on other regions. This region, at this time, is still an immature market for investors.

²⁴⁴ Industry Focus

The global car sale in the 1st half of 2016 reached more than 45 million units of vehicles , up 3% from the same period in 2015. If it is viewed by region, Europe and Asia (incl. Oceania & Middle East) both showed growth of 7% and 4% respectively. Russia/ Turkey/CIS countries, Southern & Central America and Africa, however, showed the decline of -9%, -16% and -5% respectively. Notably, the total sale in America was on a decline, but the sale in N. America showed a 3% growth. Similar to the scenario in the global car production, car sale was still concentrated In Europe, Asia and N. America. The total sale of these three regions was over 43 million units of vehicles.

Europe

Car sale in Europe in the 1st half of 2016 was nearly 10 million units of vehicles, up 7% from the same period in 2015. The sale in Europe was roughly 20% of the global sale. Top 5 countries with the highest car sale in this region were Germany, UK, France, Italy and Spain and the total sale in these five countries was about 60% of the total sale in Europe. Except for Spain in which the car sales was less than 1 million units of vehicles in the 1st half of 2016, other countries (i.e. Germany/UK/France/ Italy) in the top 5 all showed the sale of 1-2 million units of vehicles. Italy and Spain among the top 5 both showed a 10-20% growth. Car sale in each of the European countries all showed a growing trend if compared to sale in the same period of 2015, except for Switzerland showing a decline of -2.0%. The statistics also show that car sale in this region was mainly in W. Europe and the main countries with the highest car sale in E. Europe were Poland and Czech Rep.

Russia, CIS and Turkey

Car sale in this region in the 1st half of 2016 dropped by 9% from 2015 to about 1.2 million units of vehicles. Russia and Turkey were two main countries with the highest car sale in this region. In the 1st half of 2016 the total car sale in Russia was nearly 0.7 million units of vehicles while the sale in Turkey in the same period reached more than 0.45 million units of vehicles. The total sale in these two countries was over 90% of the total sale in the entire region. Although Russia showed the highest car sale in the region, its sale (if compared to the same period in 2015) still dropped by 14%. The country showing the highest growth was Ukraine. It reported up to 60% growth in sale (though the figure was comparatively low). On the other hand, sale in Serbia, Armenia and Belarus also showed growth of at least 5%.

America

The total car sale in America in the 1st half of 2016 was about 12.5 million units of vehicles (representing nearly 30% of the global sale). Like the scenario in production, sale in this region still has to be divided into North and South America for further analysis. The sale of NAFTA (USA/ Canada/Mexico) in the 1st half of 2016 increased by 3% from 2015 to roughly 11 million units of vehicles, among which USA had represented nearly 9 million units of vehicles. The sale in Canada was about 1 million units of vehicles, which showed a year-on-year growth of 5%. Sale in Mexico, though, was only about 0.75 million units of vehicles, and its growth margin was up to 20%. Quite the oppsite, sale in Southern & Central America showed a substantial drop of 16% to about 1.9 million units of vehicles. Top 5 countries with the highest car sale in this region were Brazil, Argentina, Chile, Colombia and Peru. Among

the top 5, Brazil showed the most significant drop in sale (-25%) and Colombia also showed a drop of 12%. As for Argentina and Chile, both countries showed growth of over 5%. In addition, Costa Rica, Bolivia, Dominican Rep., Nicaragua and Cuba all showed 2-digit growth in sale if compared to the same period in 2015.

Asia/Oceania/Middle East

The car sale in this region was the highest. In the 1st half of 2016, the sale reached over 22 million units of vehicles, a year-on-year growth of 4% (much higher than the sales in America and Europe). Among the top 5 countries with the highest sale (China, Japan, India, S. Korea and Australia), China, India and S. Korea all showed a 7-8% growth, even higher than the average growth of the region. China represented about 1/2 of the total sale in the region, reaching nearly 13 million units of vehicles. Japan was the only country among the top 5 showing a decline and its sale dropped by 5% from the same period in 2015. Notably, Australia has replaced Iran as the country with the 5th highest sale in the region, showing a year-on-year growth of 3%. Sale in Iran in the 1st half of 2016 dropped by 7%.

²⁴⁶ Industry Focus

Africa

The total car sale in Africa in the 1st half of 2016 was about 0.7 million units of vehicles, a 5% drop from the same period in 2015. Top 5 countries with the highest sale in this region were South Africa, Egypt, Morocco, Algeria and Libya. In addition to Morocco and Libya which showed growth of 34% and 5% respectively in the 1st half of 2016, other three countries in the top 5 all showed a 2-digit decline. Algeria among the top 5 showed the most significant drop in sale.



According to the statistics, the most important markets for car production and sale are in W. Europe, N. America and Asia. If we view by country, Germany/ UK/France/Italy in W. Europe, USA in America and China/India in Asia are all countries showing the highest car production and sale. Although the current automotive market may be influenced by President Trump's presidency and BREXIT, which may also influence the will of companies to invest or the will of consumers to buy cars, we still need more time to analyze whether the influence will be positive or not.


